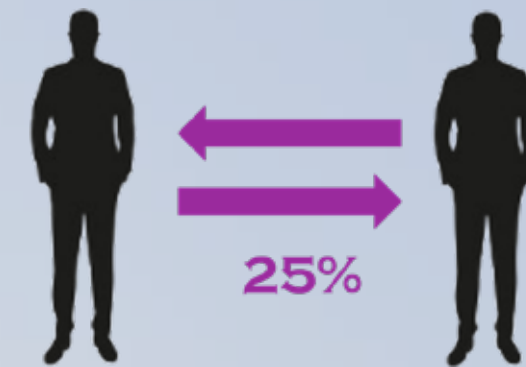

Join as an independent RiSEOO Affiliate Partner (iRAP)

To join Riseoo, you will need to fill up an application form and register yourself as a RiSEOO Affiliate Partner. This will equip you with the necessary tools RiSEOO provides for sales presentations and online sales. Once you complete the enrolment process, you carve the pathway to become a successful RiSEOOPRENEUR.

1. RETAIL PROFIT

The first income you receive is the Retail Profit. When you refer any RiSEOO product to a customer, you earn upto 25% Retail Profit. It is paid on the price of the product.



2. FAST START BONUS

The Fast Start Bonus is available to **Affiliates** who are within their **Fast Start Period***. Upon achieving the highest award tier, your sponsor may also be eligible to receive a bonus. The details for how this works are as follows:

When an Affiliate is Paid-As a specific title, they will be qualified to receive a one-time bonus. Each award tier may be achieved one time throughout the fast start period but only one award tier will be awarded in a single period. Affiliates will earn the highest award tier for which they qualify.

*Fast start period: Affiliates will be considered within their Fast Start Period for the first three months of enrollment (Joining Month + 3 months).

Active **iRAP's** receives a percentage on the **Business Volume** from the sales of their downline in the Enrollment Tree. The percentages and number of levels that an iRAP receives is based on their Paid-As Title and is regardless of the title of the people below them.

Note: This income will roll up 0 PV which means if an affiliate in your Enroller Tree is producing 0 PV. It will be skipped and the level will not be counted.

4. TEAM COMMISSION

Team Commission is designed to acknowledge the efforts of Affiliates for building teams. This income rewards you for helping and supporting your team. The more your team progresses, the more Team Commission you will earn. You build your team of Affiliates by placing them on either Side A or Side B. On sale of each Product the Affiliate generates Business Volume (BV). This Business Volume includes the spillover volume. You are paid on the matching of your pay leg (weak leg) based on your "Paid As" rank. Team Commission is recurring and is paid weekly. The percentage of Team Commission depends on your rank.

All unmatched Business Volume (BV) is accumulated in the next week's Business Volume (BV).

1. If an **affiliate** is inactive for three (3) consecutive months, then all Carry Over Volume from both the Side A and Side B will be flushed.
2. Volumes that are not paid on for 12 consecutive months will be flushed (but remaining volume may not be flushed).



5. LEADERSHIP BONUS

You get Leadership Bonus once you are Paid-As Gold Star and higher. Leadership bonus is paid on the earnings of your downline **Generations** (Career Title Black Star and Higher) in your Enrollment Tree. This is paid on both Level Bonus and Team Commission. The number of Generations that you are paid on and the percentage you are paid is based on your Paid-As Title.

Note: The maximum per match is the maximum amount you may receive on each affiliate and is based on your **Paid-As Title**. Leadership Bonus is paid quarterly.



6. CASHBACK

Direct Cashback

Direct Cashback lets you earn 10% of the cashback from all your direct Affiliates and Customers. All the customers referred by your personally enrolled customers are your direct customers.

Community Cashback

You earn 30% Community Cashback on the cashback earned by customers in your Enroller Tree. This 30% goes to the Business Volume. You are entitled to get both Level Bonus and Team Commission on the BV generated.

7. RANK ADVANCEMENT BONUS

When an Affiliate advances to the Career Titles of Black Star, Venus and Alpha Centauri for the first time, then they are eligible for Rank Advancement Bonus. This bonus is split into multiple payments and is calculated only in the monthly period.

Black Star

The Rank Advancement Bonus for this title will be split into 2 payments. The first payment will be paid with the monthly period of the advancement. The remaining payment may be earned within the following 2 monthly periods (in other words, there is a 1 month grace period) by being paid as a **Black Star** or higher title. If you are not paid as a Black Star or higher title in the 2 monthly periods following the advancement, the final payment will be forfeit.

Venus

The Rank Advancement Bonus for this title will be split into 4 payments. The first payment will be paid with the monthly period of the advancement. The remaining 3 payments may be earned within the following 5 monthly periods (in other words, there is a 2 month's grace period) by being paid as **Venus** or higher title. Any payments not earned by the end of that time will be forfeit.

Alpha Centauri

The Rank Advancement Bonus for this title will be split into 10 payments. The first payment will be paid with the monthly period of the advancement. The remaining 9 payments may be earned within the following 11 monthly periods (in other words, there is a 2 month's grace period) by being paid as **Alpha Centauri**. Any payments not earned by the end of that time will be forfeit.

8. GLOBAL BONUS POOL

The top most ranks of RiSEOO earn 1% of the company's total Business Volume (BV). This income is distributed amongst the Jupiter, Phoenix, Diamond Phoenix and the Alpha Centauri Affiliates.

The Leadership Pool is a quarterly pool that divides 0.5% of total company Business Volume (BV) by the total number of shares awarded to produce a share value. An Affiliate's earnings in this pool is determined by multiplying the number of shares they earned by the share value. An Affiliate can earn up-to 25% of this pool.

An Affiliate earns monthly shares for months that they are paid as a Jupiter or higher. Additionally, an Affiliate will only be eligible for the pool if they are paid as a Jupiter or higher at least two (2) out of the three (3) months of the calendar quarter. If an Affiliate is paid as a Jupiter or higher only once in the quarter, then any shares earned by them will be nullified and not be included in the calculation of share value.

Shares:

New 1st Generation Black Star or higher within the last 12 months: One (1) share for each Affiliate that becomes a new 1st Generation Black Star in the current month or previous 11 months and is paid as a Black Star or higher in the current month.

New 1st Generation Jupiter or higher within the last 12 months: Three (3) shares for each Affiliate that becomes a new 1st Generation Jupiter in the current month or previous 11 months and is paid as a Jupiter or higher in the current month.

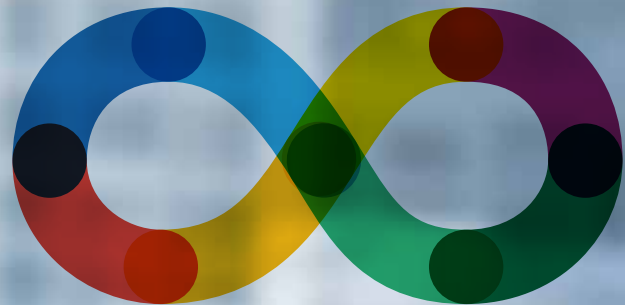

Affiliates Paid-As a Phoenix or higher receive a portion of the monthly Infinity Pool. Shares are awarded to each participating Affiliate based on their Paid-As Title for the month as mentioned in the table.

The pool divides 0.5% of total company Business Volume (BV) by the total number of shares awarded to produce a share value. An Affiliate's earnings in this pool is determined by multiplying the number of shares they have earned by the share value. An Affiliate can earn up to 25% of the total pool.

Infinity Bonus pool is paid Monthly



Glossary

Downline Volume (DV) - The total **Qualifying Volume (QV)** from an Affiliate and their entire downline organization in the Enrollment Tree.

Max Volume Rule - For purposes of title qualifications only, a maximum **DV** amount has been established where no more than a specified amount will be counted towards the Downline Volume.

DV & Legs - They are a type of career path requirement. The number following "DV-" represents the minimum amount of DV that must exist within the leg. An Affiliate's **PV** is not included in the calculation of **DV** from these legs for purposes of this requirement.

New GenQ - Jupiter and all higher titles must meet an additional requirement for both promotion and to be Paid-As their Title. To be considered New GenQ, you need to have at least **1 New 1st Generation Black Star** every 12 months (current month and previous 11 months). If you fail to meet this, then they will be Paid-As Venus.

Weekly Period - Each calendar month is broken into four weekly periods for purposes of the **Level Bonuses and Team Commission:** 1st-7th, 8th-15th, 16th-22nd, 23rd-last day of the month.
